2. The candidates shall be required to bring the following original documents for verification:
 - a. Original Certificates and Marksheet from Class X onward (Including pass certificate and marksheet of trade applied)
 - b. Tribe certificate (ST/SC/OBC)
 - c. Any one of Aadhaar card /Driving licence/voter ID card/Passport/or any identification document issued by public authority in original having clear date of birth, address etc.
 - d. Certificate of disability if apply
 - e. Resume if any
 - f. One recent passport size photograph
3. Production of documents as above in original are mandatory. The failure of the candidates to provide any of the documents before the Verification Board shall be summarily rejected and no representation whatsoever shall be entertained under any circumstances.
